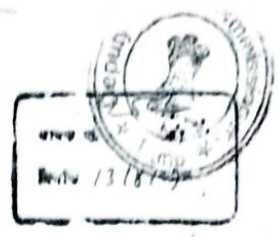




ORDER BELOW EXH.1 IN CHANGE REPORT NO.859/2007
